### USE DIRECTIONS:

- Dilution: Prepare use solutions of **ENVIRO™ Degreaser** in cold or hot water.

Application	Dilution	mL/L
Heavy to Medium Soils	1:10	100
Light Duty Cleaning	1:40	25

- **Floor Degreasing:** **ENVIRO Degreaser** may be applied with an autoscrubber, mop and bucket, brush or low pressure spray. For extremely heavy soil loads, double scrub or allow to sit for 5 minutes before final scrub and pick up. Following heavy duty cleaning with a mop and bucket, rinse or squeegee to a floor drain.
- **General Cleaning:** Apply **ENVIRO Degreaser** to surface with a spray bottle, cloth or sponge. Scrub if necessary. Rinse.

*Do not use concentrated product on latex painted surfaces – always pretest before use.*
